# Pastor updates:

- Pastor Susan
  - Sent in Holden preliminary request 30-35 spaces, they will respond with reservation (week and number of participants)
  - Jan. 15 Pastor Kelly Chapman preaching here and Pastor Susan preaching at Redeemer at 10 a.m. and staying for soul food lunch and concert to follow
- Pastor Paul
  - Base camp photo seminar available as part of Bighorn's trip this year
  - Christmas discussing adding a service, will have to tighten up services and timing

- 1925 people in attendance, 755 people at 3 p.m. people left when they saw how full it was)
- 28 people for dinner between services
- 2 candidates working with Servant Song at noon on Sunday, excellent candidates
- So thankful for where we are financially

- Get annual reports in if not done

#### Other business

- 2012 Budget
  - Changes made based on last month's meeting
  - Personnel slightly more than 2% average increase, still do not know what the increase in health insurance premium will be (budget includes some increase to reflect increase in compensation), need to confirm premiums this week
  - Supplies and expenses set based on Bill's request
  - Properties took out reserve and furnishing improvements; can use memorials or reserves if something is needed; other expenses same as last year
    - Bill and Kevin went through in detail
  - Programs same as last year except for WMA, took out \$1300 for Tent meeting sound equipment
    - Kevin will e-mail Chip about taking out sound system expenses
  - Evangelism took out Tent meeting mailing
  - Fellowship Budget less than what we spent in 2011 (consumables ended up in here in the past, have been added in Supplies and Expense)
    - Need to put a couple of dollars in the coffee basket each Sunday so people know that it is for coffee costs, not garbage
  - Kevin will send final proposed budget out to Council prior to meeting
- 2012 pledges \$304,800K currently
- 2011 giving so far 5 for 50 \$581K given; \$1,062,800 in general fund giving, great December (about \$12K under budget), lot of generous gifts at end of the year; don't yet know expenses but should be lower than budgeted deficit
  - Paul will thank people for good and faithful December (best month in history of church)
  - Mortgage balance \$1.311MM at end of November; if we could average \$20K down per month, estimate that mortgage would be paid by May 2015; Lee to look into a refinancing option to see if we can bring our interest down lower than current 6%
